
Climate support for UK pension schemes



Climate destabilisation is a key systemic risk that presents significant risks and opportunities to pension schemes. UK legislation and regulatory guidance provide a framework within which to manage climate risks, although the systemic nature does make it harder to manage than many of the more traditional risks which trustees and sponsors have tackled to date. In addition to managing this risk, many trustee boards also aspire to have a positive climate impact and believe that a pound of pension is worth more in a world worth living in.
